

Accessing the imports page

Go to the import section of the web tool for anything to do with imports



Imports checklist

Please review the following points before attempting imports:

- Decide if you really need to do imports
 - They are only suitable for units/services with a high number of cases to import (>50 per month)*
 - Units with fewer cases will find it easier to enter data directly online with fewer errors*
 - Typing data into a spreadsheet is not any quicker than entering it directly online*
 - There are technicalities and details you will need to deal with which can be challenging*
 - You may need assistance from your IT support service or technical colleagues*
- Review the import dataset specifications and guidance
- Make sure your import data file and data matches the specifications
- Make sure your import data file uses the supplied column headings/labels
- Always review the import results and correct any errors reported
- You should import your data monthly




Import dataset specifications and header file

Look for the 'datasets' on the side-bar menu to download the import dataset and header files for every supported dataset. Your data must match the import dataset and use the supplied headings/labels.



Submitting an import file
